In the indexes to the Civil Registration of births, marriages and deaths, there is a listing for a Maria Bayley whose birth was registered in the March Quarter 1850. The Maria was born in the Wolverhampton District and can be found in vol. 17, p.354. There is no Marion Bayley during this time period for this area. It is possible that our Marion is this Maria.

There is a marriage for a Marion Florence Bailey in 1880 in Birmingham in FreeBMD.org/uk and the two males on the same page are John Plant and William Frank Simons. Vol. 6d, p.162. The other female is Emma. Need to find them in the census.

Hamlet Ambrose<sup>4</sup> Bayley** (John Horatio Robert<sup>3</sup>, John<sup>2</sup>, Thomas<sup>1</sup>)<sup>103,104</sup> was born 07 Apr 1836 in Birmingham, Warwickshire, England<sup>105</sup>, and died in Pittsburgh, Allegheny County, Pennsylvania<sup>106</sup>. He married **(1) Esther Ashcroft**<sup>107,108,109,110</sup> 1859 in Wolverhampton, Staffordshire, England<sup>111</sup>, daughter of William Ashcroft and Hannah Smith. She was born ca. 16 Jul 1837 in Nottingham, Nottinghamshire, England<sup>112</sup>, and died ca. 23 Jun 1879 in Aston, Warwickshire, England<sup>113,114</sup>. He married **(2) Ellen**<sup>115,116</sup> Aft. 1879. She was born ca. 1855 in Birmingham, Warwickshire, England<sup>117</sup>.

Notes for Hamlet Ambrose Bayley:

In the 1861 census, there is a sister of Hamlet's living with them, Ada J. Bayley. She is 9, a scholar and born in Wolverhampton. There is also a boarder named William Bayley, age 11, living with them.

Note from Aunt Esther Miller, but in Frederick Spurstow Miller's handwriting:

"Grandfather and Grandmother Bayley were born in Wolverhampton, England. Grandmother B. died there and her son Neville erected a tombstone there in 1929. Grandfather died in Pittsburgh, Pennsylvania. I do not know what year. Grandmother Bayley's maiden name was Esther Ashcroft - her mother's maiden name was Duckworth." This is followed by a tree starting with Ashcroft and Duckworth. Her mother's maiden name was actually Smith, not Duckworth. Her sister Ann was married to a Duckworth.

Hamlet remarried after Esther died. He was married to Ellen in the 1881 census. The 1900 U.S. census says he emigrated in 1894. I don't know if Ellen emigrated with him or if she died before he left. No one in the family ever mentioned a second wife named Ellen.

In the 1891 Census there is a Henry Bayley, age 54, born Birmingham, WAR, solicitor's clerk, law. He

is married to Ellen, age 32, born Birmingham, WAR. They are living at 212 Liverpool Rd., in London, Civil Parish of Islington, Eccles. Parish of St. Mary's. There is a son, Harold, age 3, living with them, born London, Clerkenwell. There is a birth registered in the District of Holborn, which includes the township or parish of CLerkenwell, and which spans the boundaries of the counties of London and Middlesex. This Harold was listed as Harold John Bayley, birth registered March Qtr, 1888, vol. 1b, p.731. It is possible that this is Hamlet Bayley and his wife Ellen. If so, what happened to Ellen and Harold when Hamlet moved to the U.S.?
