Descendants of Richard Illidge of Cheshire

First Generation

1. Richard Illidge¹ was born in 1637 in Weston, Cheshire, England, ² died 12 Jun 1709 in Nantwich, Cheshire, England³ at age 72, and was buried 14 Jun 1709 in Wybunbury, Cheshire, England. ⁴

General Notes: According to Lt. Richard Illidge's diary, his father was of Cherlton [Chorlton] and his mother was Cecilia Chesnis of Mickley in Wrenbury Parish. Richard was born in Weston, parish of Wybunbury in Cheshire in 1637. He was a younger son with three brothers and was apprenticed to a shoemaker in Nantwich when he was fifteen. He followed this trade for a number of years in various places, including London, before returning to Nantwich in 1660 - 1661. He married Mary, the daughter of Richard Price and the widow of William Minshull. When he was about forty he "took a rack lease of a farm called Cheer Brooke in Stapeley, near Nantwich and lived there for the next thrity years." [A rack rent refers to an excessive amount of rent which a landlord charged to a tenant]. He lived on this farm for the next thirty years.

Richard had four sons but he outlived all of them but his son George. His wife, Mary, who was a widow, also had children which Richard must have raised. He mentioned them in his will. He joined the Cheshire militia and was a member for fifty years. During this time he began to live a life of drunkeness and profanity. He later gave up these "wicked ways" and became very religious, wrote a diary of his life and many papers on living a moral and virtuous life. In among his papers was one of advice to his three young granddaughters: Elizabeth, Mary and Martha. He was 67 at the time, and tells them to be loving and dutiful to their father; that their mother, who died when they were very young, was a pious, modest and good woman. He also tells them that he had three brothers but that they are all dead now. This would have been about 1704. He died a few years later, 12 June 1709, age 72, and was buried in the Churchyard at Wybunbury, Cheshire.

Noted events in his life were:

Will: 29 Apr 1709, Chester, Cheshire, England. ⁵ George Illidge, Richard's only surviving son, was
the executor of the will. Most of his estate went to his wife and son George. He left his granddaughter
Elizabeth a silver tankard and a large new Bible. Her two younger sisters received a guinea each.
Also mentioned in in the will are the children of his wife and her first husband William Minshull:
Richard, Thomas, Elizabeth and Ann.

Richard married Mary Price 29 Mar 1662 in Nantwich, Cheshire, England. 6

General Notes: Mary was said to be the daughter of Richard Price, shoemaker in Nantwich. She was first married to William Minshull, and after his death, she married Richard Illidge.

In his will Richard leaves much of his estate to his wife. A Mary Illidge, wife of Richard, was buried 5 July 1671 in Nantwich, Cheshire. Richard does not mention the death of his wife and remarriage, so that Mary Illidge would probably not be Mary Price Illidge.

The child from this marriage was:

Second Generation (Children)

2. George Illidge^{7,8} (Richard 1) was christened 4 Jan 1663 in Nantwich, Cheshire, England. 9

General Notes: Our family trees and charts show that George Illidge was married to Mary Croxton 15 Apr 1693 in Wybunbury. Mary would have been a second wife as George had three daughters with his first wife: Elizabeth, our ancestor, Mary and Martha, christened between 1687 and 1691. The daughters were very young when their mother died. We know this from their grandfather's writings. Lt. Richard Illidge, George's father, wrote words of advice to his three granddaughters in 1704. They would have all been in their teens. In it he mentions their mother who died young.

There is a burial for an Ellen Illidge on 6 Aug 1691 in Nantwich, Cheshire, spouse named George. This is very likely George's first wife. Their youngest daughter, Martha, was christened in June 1691 and George remarried in 1693. There is also a marriage in Nantwich between an Ellen Seavill and George Illidge on 27 July 1686, the year before Elizabeth, the oldest daughter, was born. FamilySearch.org database: England, Cheshire Bishop's Transcripts, 1598-1900, Burial of Ellen Illidge, 6 Aug 1691, Nantwich, Cheshire, FHL MF 1786141, img 151. Her burial is also recorded in the Parish registers.

Family records also name him as George Illidge Jr. but in all three of his daughters' christening records, he is listed as George Illidge, shoemaker - no Junior. His father was Lt. Richard Illidge who was also a shoemaker. He was one of four sons and the only one to outlive his father. He was the executor of his father's will and given, among other items, all his father's books.

It was George who got his father in touch with his friend Matthew Henry who wrote up and published Richard's diary. The diary gives a few details of his life, the change in his life from a drunk and wicked life to one of morality, religion and social concern.

George married someone.

her father is a shoemaker.

His children were:

One on 26 Dec 1688 in Wybunbury, Cheshire, and one on 19 May 1689 in Nantwich, Cheshire. Either one could be the sister of Elizabeth and Martha, both of whom were christened in Nantwich, not Wybunbury. I have chosen the christening for Nantwich because
 - 5 F iii. **Martha Illidge**¹⁵ was christened 21 Jun 1691 in Nantwich, Cheshire, England ¹⁵ and was buried 26 Mar 1714 in Wybunbury, Cheshire, England. ¹⁶

George married **Mary Croxton** 15 Apr 1693 in Wybunbury, Cheshire, England. ¹⁷ Mary was buried 2 Oct 1728 in Chester, Cheshire, England. ¹⁸

Marriage Notes: Notes handed down in the family said that George Illidge and Mary Croxton were the parents of Elizabeth Illidge Spurstow, but Elizabeth was born before their marriage in 1693. Elizabeth and her sisters were very young when their mother died. Their father remarried, presumably to Mary Croxton. The marriage record lists him as George Illidge Jr., but his father was Richard. Perhaps Elizabeth's father, George, married a different woman after his first wife died, and Mary Croxton was the wife of a different George Illidge - there were several by that name.

Third Generation (Grandchildren)

3. Elizabeth Illidge¹⁰ (George², Richard¹) was christened 14 Jul 1687 in Nantwich, Cheshire, England ^{11,12} and died about 1757¹³ about age 70.

General Notes: Elizabeth Illidge was the oldest of three daughters born to George Illidge and his first wife in the Nantwich area of Cheshire. Her father was a shoemaker and her mother died when she and her sisters were very young, before 1693 when her father married Mary Croxton.

There is a burial for an Ellen Illidge on 6 Aug 1691 in Nantwich, Cheshire, spouse named George. This is very likely George's first wife. Their youngest daughter, Martha, was christened in June 1691 and George remarried in 1693. There is also a marriage in Nantwich between an Ellen Seavill and George Illidge on 27 July 1686, the year before Elizabeth, the oldest daughter, was born.

Nantwich is in Cheshire, about 5 miles from Bunbury, where Elizabeth's husband, John Spurstow, was from.

There is a will written by Elizabeth Spurstow, widow, in 1756, probated in 1757, in which she mentions her late husband. If this is Elizabeth Illidge Spurstow, then her husband would be John, whose will was probated in 1769, long after his wife had died. Both wills mention sons John and George, but more research needs to be done to verify whose wills these actually are.

Noted events in her life were:

 Will: 2 Jul 1756, Manchester, Lancashire, England. ¹⁹ 2 sons mentioned in will: John and George. Probate was 9 Sept 1757.

Elizabeth married **John Spurstow**, 20 son of **Charles Spurstow**, 4 Nov 1716 in Bunbury, Cheshire, England. 21,22,23,24 John died in 1749. 7

Noted events in their marriage were:

Marriage/Church: Bunbury Church in Wybunbury, 4 Nov 1716.²⁵

General Notes: This John Spurstow is probably the son of Charles Spurstow, baptized at Bunbury, Cheshire, England, 13 November 1662, and buried there 17 June 1685. This comes from a Spurstow Chart called The Spurstows of Spurstow taken from "The Publications of the Harleian Society, V.17" and sent to me by Hope Healy Koontz.

A John Spurstow wrote a will (attributed in the family history to this John) in 1649. His wife is still alive but not mentioned by name. She, along with son John and Mr. George Croxton of Manchester, are named as executors. When the will was probated in 1769, John was the only surviving executor. He names his two sons, George and John in the will and leaves a silver tankard to his grandson George Spurstow. If this is the correct John Spurstow, he had two grandsons named George. He must have been referring to the first one, born to his son George's first wife, Elizabeth. This George died in 1751. The second grandson named George was not born until 1761, to son George's 2d wife, Elizabeth Hayes. The first grandson George could have been born by 1749 when the will was written. The second grandson George died in 1783, age about 22, and supposedly had not married. He supposedly had a half brother John who died in 1789, also unmarried. John Spurstow's wife, Elizabeth Illidge's mother was Mary Croxton. This would account for the Croxton relations. Until other findings say otherwise, I am assuming that this is the will of John Spurstow who died in 1769 and whose wife was Elizabeth Illidge.

THERE IS A PROBLEM WITH THIS HOWEVER...

Elizabeth wrote her will in 1756 and she was a widow. She names her sons John and George. I think the 1769 date might be the wrong probate date for this will. This needs a lot more research.

Also, a John Spurstow, of Manchester, declared bankruptcy in 1756. This was reported in a list of bankruptcies listed in Berrow's Worcester Journal on 26 Aug 1756. http://freepages.genealogy.rootsweb.ancestry.com/~dutillieul/ZOtherPapers/NewBWJ26Aug1756.html: Some Selected Reports from Berrow's Worcester Journal, Thursday, 26 Aug 1756.

Fourth Generation (Great-Grandchildren)

6. George Spurstow "Apothecary"^{28,29} (*Elizabeth Illidge* ³, *George* ², *Richard* ¹) was born about 10 Feb 1717 in Chester, Cheshire, England, ²⁷ was christened 10 Feb 1717 in Chester, Cheshire, England, ^{30,31} and was buried 12 Jan 1770 in Chester, Cheshire, England. ^{33,34}

Burial Notes: the burial record says 1769 which was really 1770 since the new year began in March General Notes: There are several George Spurstows. This George is the apothecary. It is mentioned in the baptisms of his children and at his burial.

Noted events in his life were:
• Occupation: Apothecary. 27,36

- Civic Status: Freeman, 13 Jul 1747, Chester, Cheshire, England. 37 p.332: George Spurstow, apothecary, s. of John Spurstow of Chester, merchant. Freedom granted by Order of Assembly

George married Elizabeth. Elizabeth was buried 29 Jan 1754 in Chester, Cheshire, England. 38

General Notes: Elizabeth was the first wife of George Spurstow, b. 1716/17. She died in 1753 after having at least two children with George. She is buried in St. Martin's churchyard, Chester, Cheshire. The burial record notes that she was the wife of George Spurstow, Apothecary.

There is a marriage record for a George Spurstow and Ann Grace, 1748. He was from Chester but the marriage took place in nearby Hargrave. There is no marriage record for George Spurstow and the 1st Elizabeth that I have found. Not sure who George Spurstow and Ann Grace were.

Family records show that there was a son John born about 1737, but no baptismal record has been found for him. Daughter Ellen was in the family records as born in 1739, but her christening was in 1750 so both Ellen's and John's birth dates may be wrong. John's baptism may have been in thre nonconformist church where his two sisters were baptized, so a record might be found there and it might be for a date closer to 1749-50. There is also a burial for a George Spurstow, son of George Spurstow. Apothecary, who was buried in 1750/51. No record of his birth or baptism has been found yet.

Children from this marriage were:

i. **John Spurstow**³⁹ was born about 1737³⁹ and died 30 Aug 1789 in Chester, Cheshire, England³⁹ about age 52. 8 M

General Notes: John was the last Spurstow.

ii. Ellen Spurstow³⁹ was born 8 Nov 1750 in Chester, Cheshire, England ³⁹ and was 9 F christened 27 Nov 1750 in Chester, Cheshire, England. 41

> Christening Notes: Ellen was baptized at the Crooke Street Presbyterian or Unitarian Church in Chester, a non-conformist church

General Notes: Handwritten Notes of Francis Spurstow Miller, 1863-1901, on the Miller family tree, 1936, gives Ellen's birth as 1739. No record has been found for an Ellen Spurstow for that date but there is one for 1750. Not knowing where his information came from, I am going to go with the parish baptismal and birth records.

iii. George Spurstow was buried 14 Feb 1752 in Chester, Cheshire, England. 42 10 M

> General Notes: This George Spurstow's burial record notes that he is the son of George Spurstow, Apothecary. No christening for this George has been found yet, so his order in the family is unknown. George Spurstow, his father, married a second time and had another son, also named George. Buried 1751/52.

iv. **Elizabeth Spurstow** was born 21 May 1752⁴³ and was christened 9 Jun 1752 in Chester, 11 F Cheshire, England, 43

Christening Notes: Christened at Crooke Street Presbyterian or Unitarian Church in Chester.

General Notes: There are two Elizabeths in this family. This Elizabeth is the first one. The second Elizabeth was born in 1759 to George Spurstow's 2d wife, Elizabeth Hayes. The first wife, also Elizabeth, died in 1753, but no record has turned up yet for the burial of the Elizabeth born in 1752. This Elizabeth and her sister Ellen were both baptized in a non-

conformist church in Chester. The younger children were baptized in the Church of England.

George next married **Elizabeth Hayes**^{7,44} 2 May 1754 in Tattenhall, Cheshire, England. ^{27,45,46,47} Elizabeth was buried 12 Mar 1778 in Chester, Cheshire, England. ⁴⁹

Marriage Notes: Marriage was at the parish church, St. Alban's. This was the 2d marriage for George Spurstow and the first for Elizabeth Heays/Hayes. George had two or more children with his first wife, Elizabeth. Elizabeth Hayes and George were married with parental consent so Elizabeth might have been much younger than George. The marriage was in the parish church of Tattenhall and George was of the parish of St. Peter's, Chester. They were married by license.

There is a transcription of the marriage in FamilySearch.org for George Spunstow and Elizabeth Heas which gives the date of marriage as 2 May 1757 - but this is a transcription error since the date is 1754. A look at the image on FHL MF 1836287, image 370, shows other dates on the page as 1754 and 1755.

General Notes: According to notes of Hope Healy Koontz, who researched the Millers, Elizabeth Hayes Spurstow died without a will. Her daughter Mary Spurstow Miller was appointed to administer her estate. The date of 18 Nov 1781 is the date that her daughter was appointed to administer the estate. The family pedigree chart gives this date as her date of death but her burial date was 12 Mar 1778 according to the parish records.

According to a family tree that was handed down in the Miller family, Elizabeth Bagnall, or Bagnell, was the wife of George Hayes (Heays) and they were the parents of Elizabeth Heays who married George Spurstow in 1754. So far, though, no christening as been found that shows Elizabeth to be George and Elizabeth's daughter. Additionally, a document in the Cheshire Archives, DHL/41/1 3 July 1801, states that Elizabeth, wife of George Spurstow, apothecary, city of Chester, was the only daughter of John Heays, "heretofore of Eastham, yeoman, deceased..." So it seems that Elizabeth's parentage according to the family tree handed down is probably not correct. For now, Elizabeth's father is probably John Heays/Hayes, mother unknown, and her Bagnell ancestry is in question.

Noted events in her life were:

- · Name Fact: Also spelled Heays.
- Probate: Died intestate, 1778, Chester, Cheshire, England.

12 F i. Mary Spurstow⁵¹ was born about 1 Jun 1756 in Chester, Cheshire, England, ⁵² was christened 1 Jun 1756 in Chester, Cheshire, England, ^{53,54,55} died 30 Jan 1832 in Cheswardine, Shropshire, England, about age 75, and was buried in Cheswardine, Shropshire, England. ⁵⁶

General Notes: Mary was a widow when she died. Her husband, William, died in 1826, age 78. In 1834 her son, Rev. Charles H. Miller, was the curate of St. Swithun's in Cheswardine, Shropshire, England. In the graveyard of the church there is a headstone for Mary, "relict of Wm. Miller" and her daughter Ellen, age 65, who died in 1850. Mary and her daughter were probably living with Charles and his family after William Miller died.

Mary married **William Miller**, ^{57,58} son of **John Miller**⁶¹ and **Margaret**, ⁶¹ 21 Sep 1779 in Chester, Cheshire, England. ^{59,60} William was born about 14 Oct 1751 in Kendal, Westmorland, England, ⁶² was christened 14 Oct 1751 in Kendal, Westmorland, England, ⁶³ and died 11 Aug 1826 in Liverpool, Lancashire, England ^{64,65} about age 74.



General Notes:

William Miller is listed in the parish registers of St. Nicholas Church, Liverpool, as a mercer and draper from the 1782 christening of his daughter Elizabeth; from 1788 until 1800 he is listed as a silk mercer

at his children's christenings.

Noted events in his life were:

- Baptism: Holy Trinity Church, 14 Oct 1751, Kendal, Westmorland, England. 66
- Education: ca. 1765, St Bees, Cumbria, England. ⁶⁷ Attended St. Bee's School, a boarding school for boys west of William's home in Kendal.
- Business Dealings: 20 Jun 1777, Liverpool, Lancashire, England. ⁶⁸ "Messrs. Miller and Co. take this method of acquainting their friends and the public, that they have taken Mr. Elkington's shop, No. 13, in Atherton Street, where the trade will be carried on by them in all its branches, entirely for ready money."

General Notes: Notes from Hope Healy Koontz say he was a Liverpool broker.

14 M iii. **George Spurstow**⁷⁹ was born in 1761,⁷ was christened 18 May 1761 in Chester, Cheshire, England,⁸⁰ and died in 1783⁷ at age 22.

15 F iv. Dorothy Spurstow⁴⁸ was born in 1763 in Chester, Cheshire, England, ^{81,82,83} was christened 13 Sep 1763 in Chester, Cheshire, England, ⁸³ and died 20 Sep 1828 in Parkgate, Cheshire, England ^{7,48} at age 65.

General Notes: Mentioned in her will are daughters Mary, Anne, Elizabeth, Martha, Ellen, Esther, sons Charles and William John, and nephews William and Rev. Charles.

Dorothy married **Dr. John Tomlinson**, 48,84 son of **Randle Tomlinson**, 48,84 and **Ann Bagnell**, 48 9 Feb 1786 in Chester, Cheshire,
England. 55,86,87 John was born about 1759 in Plemstall, Cheshire, England, 48,88 was christened 18 Jan 1759 in Plemstall, Cheshire, England, 69,90 died in 1808 in Chester,
Cheshire, England 48,91,92 about age 49, and was buried 26 Jul 1808 in Handley, Cheshire, England. 92,93

General Notes: There is a burial in the parish registers for a John Tomlinson, 26 Jul 1808, in Handley, Cheshire. Although he died in Chester, there is no record of a burial for him there. His wife, Dorothy, who died in 1808, also has no burial record in Chester, where they used to live. She died in Parkgate, Cheshire, which is further west. There is a burial for a Dorothy Tomlinson in a place called Hamner in Flintshire, Wales. This is not far from where she died and not far from Handley. This may be our John and Dorothy Tomlinson but more research would need to be done to confirm this.
